


The college is registered under 2 (F) and 12 B of UGC Act for the purpose of Grants in aids etc. from University Grants Commission

1. The Moot court room is well built like real Court Room with the chair of Judge witness Box. The protected enclosure for the accused. The Moot Court practical are held regularly.







## ADMISSION DETAILS

### Eligibility Criteria:-

The graduates / and equivalent (Three years degree course) of recognized universities are eligible for the admission in the college. A bachelor degree course in any discipline passed candidates of Vinoba Bhave University under 10+2+3 or 4 pattern or equivalent there to.

According to Bar Council of India securing at least 45% marks (in case of SC / ST / OBC 40% marks) in the aggregate will be eligible to appear at the Entrance Examination which are held to select candidates for admission to LL.B part –I in this college.

- (1) Admission will be given to those candidates who are selected in entrance examination.
- (2) The candidates of SC / ST / OBC / Minority will be admitted as per the regulation of University.
- (3) 50% seats are reserved for minority community. If the seats are vacant, it will be open for other categories.
- (4) Application forms duly completed must reach the college office on or before the last date fixed for that purpose.
- (5) Five copies of passport size photographs may be submitted along with the application form.
- (6) Students migrated from other university are required to submit migration certificate along with migration fee within one month of being admitted. Failure to do so may result in cancellation of admission.
- (7) The applicant must prove that he is a graduate from a recognized university by producing original Bachelor's Degree, Original Mark sheet and Original College Leaving Certificate (C.L.C.). The original Degree and Mark sheet will be returned to the student but the original C.L.C. shall not be returned in any case.
- (8) The photocopy of caste certificate in case of SC / ST / OBC candidates.

## Fee Collection

- (A) Course fee are collected at the cash counter of the College, fixed in that session notified by the college.
- (B) There is no provision for free students – ship in the College and there is no other Provisions for financial help to student.
- (C) Student once admitted due annual fee will be paid by the students, there is no provision for return of fee once the fee is deposited

- (D) The stipends are given to reserved category of students such as ST / SC / OBC by the Welfare Deptt. of State Govt. as per rules. They are required to submit their application to the concerned Govt. Deptt.-through Principal.
- (E) The Minority students are also given stipends by the State / Central Government as per the criteria fixed by the concern Govt. Authority.

## **OFFICE HOURS:-**

The office will function from 9:30AM to 5:00P.M. Suspension of lecture on any day does not mean the suspension of the office work on that day. The office remains open during vacation from 9:30AM to 5:00P.M.

## **TEACHING HOURS:-**

Classes are held in the day hours from 10:30 A.M to 5:00 P.M but it may vary according to circumstances. The class hours are indicated in the class routine and may be changed as and when required under special circumstances for the tutorial and moot court classes.

## **DRESS CODE:**

There is a proper dress code for all girls & boys students. If those students who do not come in proper dress, they will not be allowed to attend classes. Dress is mandatory for all students and fine may be imposed and invite discipline action in case of not attending classes in Dress.

## **PROHIBITION OF RAGGING:-**

Ragging is serious crime and it is totally prohibited in the college. Those who are involved in the ragging may be expelled and if they are caught second time they will be punished and given **CLC** by the college.

## **COURSES OFFERED :-**

The college is presently imparting 3 years LL.B. Course and the College intends to start other law Courses with due permission from the authority concerned.

## **Courses of Study:-**

The teaching and instructions shall be in accordance with the Bar Council of India Rules & V.B.U. The candidates admitted to the course shall pursue the courses of study.

## **Duration of the Course:-**

The duration of the course leading to the Bachelor's Degree in Law (LL.B) shall be of three academic years.

## **Attendance at Lectures**

1. No students will be deemed to have completed regular courses of study for one year unless he attended a minimum of 75% of lectures in each subjects prescribed for study, in general, tutorial and moot-court lectures.

A student who has not completed a regular course as indicated (1) will not be eligible to be standing for the university examination in that course he will have to be readmitted to same course again in other session, unless has shortage of attendance condoned by the vice-chancellor as indicated.

## 5. Syllabus

**5.1** The syllabus in each subject and in each paper will be demarcated into well defined units/areas of contents along with a topic wise break up. The Board of studies of subjects constituted by the Vice-Chancellor shall be responsible for framing the syllabus subject to the provisions of regulations.

**5.2 .1** the syllabus of LL.B Part-I shall comprise eight papers of one hundred marks each, out of which one paper shall be optional.

**5.2.2** The syllabus of LL.B. Part-II shall comprise ten papers of one hundreds marks each, out of which one paper shall be optional. The papers pertaining to Moot-Court (Compulsory Paper) and professional ethics (Compulsory Paper) shall be divided into two parts-written and viva- voce examination. The Written and Viva-Voce portions of a Paper shall have 70 and 30 percent marks respectively portion wise passing in there papers separately shall be essential.

**5.2.3.** The LL.B. Part-III examination shall comprise ten papers of one hundred marks each, out of which one paper shall be optional. The compulsory paper of 100 marks drafting, pleading and convincing-shall be divided into two portions-Written and Viva-Voce examination carrying 70 and 30 marks respectively passing in each portion of the paper shall be essential.

**5.2.4.** Each theory of the University Exam. Shall comprise ten questions out of which five have to be answered; the theory paper shall be of three hours duration.

### **7.0 Eligibility for taking Examination:**

**7.1** The Examination form of only such candidates who have:

- (a) Fulfilled prescribed attendance Criteria, and
- (b) Good moral character shall be forwarded to the examination department of the University for Issuance of admit-card.

### **8.0 Minimum Pass marks and must classification of successful candidates:**

**8.1 (a)** No candidate shall be admitted to the LL.B.-Part-II unless he/she has passed in fifty percent of prescribed paper of LL.B. Part-I and not less than forty five percent marks in the aggregate of the four papers (i.e. 180 marks) conduct by V.B.U.

**(b)** No candidate shall be admitted in LL.B> Part-III unless he/she has passed in fifty percent of prescribed papers of LL.B. Part-II separately and not less than forty five percent of marks in the aggregate of five papers i.e. 225 marks subject to the provisions in clause 5.2.2.

**(c)** A candidate shall be allowed to appear in LL.B. Part-III only if he/she has cleared all the papers if LL.B.-I and II examination.

**(d)** For passing in a theory paper a minimum of 33% is required, whereas in viva-voce examination a minimum of 50% is required. However for passing in one part of LL.B. examination a minimum of 45% marks in aggregate shall be essential.

**(e)** If a candidate passes in all the papers individually but fails in then such a student may be allowed to re-appear in as many papers as he/she desires in order to enable him/her to pass the examination.

## **8.2 Classification of successful candidates:**

At the end of the LL.B. Part-III examination the successful candidates shall be classified as under:  
1<sup>st</sup> class with distinction 75% all the above in the aggregate of all the three parts of examination provide the candidate class all the papers in one attempt of examination.

1<sup>st</sup> class: 60% or more in all the three parts if examination's taken together examination's.


2<sup>nd</sup> class: 45% or less than 60% marks in the aggregate of all three parts of the examination.

## **9.0 Reappearance at the Examination:**

A candidate who clears 50% of total prescribed papers with an aggregate forty five percent marks in all the cleared papers taken separately in LL.B. Part-I may be allowed to appear at the next annual examination in only in all papers if he/she so desires, the candidate who in the next annual examination.

The scheme of reappearance in LL.B. Part-I shall be applicable to LL.B. Part-II candidate also.

The candidate who fail/or fails in maximum of 50% papers in LL.B. Part-II may appear likewise in the next supplementary examination to the date of publication of the result of annual examination. However a candidate who fails to appear or fails in the supplementary examination may appear in the next annual examination.
